**Notification of Change in Dealing Deadline**

Dear Shareholder

We are writing to you as a Shareholder in the Company. The purposes of this letter is to notify you that it has been determined to change the dealing deadline for each of the above listed Funds.

Capitalised terms used in this letter and not otherwise defined shall have the meaning set out in the prospectus for the Company or the Fund's supplement as appropriate.

**1. Notification of Change in Dealing Deadline in respect of each of the Funds**

The Supplements for each of the above Funds currently provide that the Dealing Deadline is *"1.00 p.m. (Dublin time) on the relevant Dealing Day."*

The Directors of the Company have now determined to amend the Dealing Deadline for each of the Funds such that the Dealing Deadline shall be *"2 p.m. (Dublin time) on the relevant Dealing Day."*

**2. Changes specific to Bloomberg Commodity CMCI SF UCITS ETF; CMCI Commodity Carry Ex-Agriculture SF UCITS ETF; CMCI Commodity Carry SF UCITS ETF; CMCI Composite UCITS ETF and CMCI Ex-Agriculture SF UCITS ETF**

The names of the Reference Index of each of these Funds will be amended to remove reference to "Bloomberg" therein, such that the index names will now be as follows:
